It shall be a condition of approval that each site holder shall hold the society blameless and indemnified against legal proceedings from such incidents of accidents. It is agreed that the Emerald Show Society will not, under any circumstances, be held responsible for any loss or damage to the stock in trade, equipment, stalls, etc. or any part thereof belonging to an exhibitor.
- **SECURITY:** The Emerald Show Society will provide roving security during Monday and Tuesday nights.
